Cookie Policy

This policy is designed to help you understand more about how and when we use cookies on our applications, sites, services and tools and the choices you have. This cookie policy applies to the App and website Rispondo.io

1. Cookies

We use cookies, web beacons, flash cookies, HTML 5 cookies, pixel tags and other web application software methods (collectively “cookies”) that are essentially small data files to store information in your web browser or on your mobile phone, tablet, computer, or other devices (collectively "devices") that allow us to store and receive certain pieces of information whenever you use or interact with our applications, services, sites and tools.

We use the following types of cookies:

Session cookies expire at the end of your browser session and allow us to link your actions during that particular browser session.

Persistent cookies are stored on your device in between browser sessions, allowing us to remember your preferences or actions.

First-party cookies are set by Rispondo.io

Third-party cookies are set by a third party, i.e. an authorized service provider of Rispondo.io.

2. Rispondo.io use of cookies

As we update and improve our services the specific cookies we use may change from time to time, but they will generally fall into one of the below categories:

| Categories of Use | Description |

| Authentication | If you're signed in to Rispondo.io, cookies help us show you the right information and personalize your experience. |
| Security | We use cookies to enable and support our security features such as identifying irregular site behavior, prevent fraudulent activity and improve security and violations of our Terms of Service. |
| Preferences, features and services | These cookies can tell us which language you prefer and what your communications preferences are and store such preferences and other information. They can also help you fill out forms on the Rispondo.io service more easily. |
| Performance, Analytics and Research | Cookies help us learn how well our site, services and tools perform in different locations. We also use cookies to understand, improve, and research products, features, and services, including when you access |

Rispondo.io from other websites, applications, or devices such as your work computer or your mobile device.

When you visit our website Rispondo.io, your prior consent is always requested before replacing any cookies except for the ones that are required for the operation of our website. If you do not consent, only limited visit statistics will be gathered without installing any cookies via our audience measurement tool which we use for the proper administration of our website in accordance with the guidelines published by data protection authorities in the EU.

3. Third party use of cookies

We may work with third-party companies, commonly known as service providers, who are authorized to place third-party cookies for storing information on our sites or in our services, applications, and tools with our permission. These service providers help us deliver our own content and compile anonymous site metrics and analytics and to provide you with a better, faster, and safer experience.

These service providers are subject to confidentiality agreements with us and other legal restrictions on their use or collection of any personal information. Third-party cookies are covered by the third parties' privacy policy.

4. Your cookie options

Most browsers allow you to control cookies through their settings preferences. However, if you limit the ability of websites to set cookies, you may limit your user experience as it may stop you from saving customized settings like login information and other personalized preferences. In addition most browsers also provide functionality that lets you review and erase cookies, including Rispondo.io cookies. Please note that some Rispondo.io functionality may stop working properly without cookies.
